A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO NEGOTIATE THE PURCHASE OF THREE (3) PARCELS OF LAND WITH A TOTAL AREA OF SIXTY THOUSAND (60,000) SQUARE METERS IN THE AMOUNT OF ONE MILLION PESOS (Php1,000,000.00) LOCATED AT BARANGAY AGOS, MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO FOR THE ESTABLISHMENT OF SANITARY LANDFILL

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 9, 2018 requesting to pass a resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to negotiate the purchase of Three (3) Parcels of Land with a total area of Sixty Thousand (60,000) Square Meters in the amount of One Million Pesos (Php1,000,000.00) located at Barangay Agos, Municipality of Gloria, Province of Oriental Mindoro for the establishment of Sanitary Landfill;

WHEREAS, the implementation of RA 9003 otherwise known as the Solid Waste Management Act is strictly enforced by the national government;

WHEREAS, this municipality is maintaining an open dumpsite which is no longer authorized under the said Act and this LGU has been warned to strictly comply the regulation of RA 9003;

WHEREAS, to comply RA 9003, there is a need to acquire lot for the establishment of Sanitary Landfill;
