

RESOLUTION NO. 2018-191

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A CONTRACT OF AFFILIATION BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE LUNA GOCO COLLEGES REPRESENTED BY ITS HEAD-SOCIAL WORK DEPARTMENT, MS. MARITESS B. DE GUZMAN, RSW, MSW FOR THE FIELD PRACTICUM II (WORKING WITH COMMUNITIES) OF THEIR TWO (2) BACHELOR OF SCIENCE IN SOCIAL WORK STUDENTS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated November 28, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Contract of Affiliation by and between the Municipality of Gloria and the Luna Goco Colleges represented by its Head-Social Work Department, Ms. Maritess B. De Guzman, RSW, MSW for the Field Practicum II (Working With Communities) of their two (2) Bachelor of Science in Social Work students;

WHEREAS, Section 444 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the *Sangguniang Bayan* or pursuant to law or ordinance;

WHEREAS, the Contract of Affiliation to be entered into by and between the Municipal Government of Gloria, represented by the Honorable Municipal Mayor German D. Rodegerio, and the Luna Goco Colleges represented by its Head-Social Work Department, Ms. Maritess B. De Guzman, RSW, MSW, defines the terms and conditions intended for the affiliation and training of two (2) students taking up Bachelor of Science in Social Work so as to ensure high level of competency and exposure upon graduation in the said tourism course;

WHEREAS, Ms. Julie Ann R. Lomio and Ms. Marijo Alcaria will undergo Field Practicum II as an integral part of the social work curriculum which the BSSW students are required to complete successfully prior to taking the board for social workers. Under this course, students are provided with an educationally-directed, coordinated and monitored field experience under this supervised, direct service activities for them to build on knowledge and skills and apply theory from all foundation areas with focus in working with communities;

WHEREAS, they are required to render 500 hours to finish the course and upon submission of the required course output;

WHEREAS, a contract of affiliation by and between Luna Goco Colleges represented by its Head-Social Work department, Ms. Marites B. De Guzman, RSW, MSW and the municipality of Gloria represented by Hon. German D. Rodegerio is necessary in the implementation of Field Practicum II;

WHEREAS, the body finds that the request to be of merit.

NOW THEREFORE, on motion of **Hon. Lauro L. De Belen, Chairperson**, Committee on Education, Culture and Arts and was duly seconded by Hon. Felix V. Jarabe III, so be it;
