**RESOLUTION NO. 2018-193**

**A RESOLUTION AUTHORIZING THE LEAD BARANGAY AGOS REPRESENTED BY HON. ERICKSON M. SEMILLA, BARANGAY CAPTAIN TO CONSTRUCT CATEGORY I SANITARY LANDFILL IN THE PARCEL OF LOT (LOT E) OWNED BY THE MUNICIPAL GOVERNMENT OF GLORIA WITH TRANSFER CERTIFICATE OF TITLE NO. 064-2018005240 WITH AN AREA OF SIX (6) HECTARES LOCATED AT BARANGAY AGOS, GLORIA, ORIENTAL MINDORO**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter dated December 7, 2018 requesting to pass a resolution authorizing the Lead Barangay Agos represented by Hon. Erickson M. Semilla, Barangay Captain to construct Category I Sanitary Landfill in the parcel of lot (Lot E) owned by the Municipal Government of Gloria with Transfer Certificate of Title No. 064-2018005240 with an area of Six (6) Hectares located at Barangay Agos, Gloria, Oriental Mindoro;

**WHEREAS**, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that: Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental of its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of the inhabitants;

**WHEREAS**, RA 9003 otherwise known as the Ecological Waste Management Act of 2000 mandates every local government unit to establish their respective Sanitary Landfill for proper waste management;

**WHEREAS**, this municipality is maintaining an open dumpsite which is no longer authorized under the said Act and this LGU has been warned to strictly comply the regulation of RA 9003;

**WHEREAS**, to comply RA 9003 otherwise known as the Solid Waste Management Act, the Municipality of Gloria is proposing the establishment of functional sanitary landfill (SLF) in a one (1) hectare of land out of the six (6) hectares owned by the Local Government Unit of Gloria classified under Category 1 to serve as the final disposal facility for the waste generated by the 27 barangays of the municipality at an approximate waste volume of 16.22 tons per day;

**WHEREAS**, the Municipality of Gloria, Province of Oriental Mindoro is a fast developing town and is now being regarded as the newest business hub in Southern Oriental Mindoro;

**WHEREAS**, considering the growing population, the volume of waste generated considerably increased, hence it is imperative to address this menacingly creeping problem;

**WHEREAS**, the municipality has enacted its local version of solid waste management and is now vigorously implementing such ordinance in harmony with the policies enshrined in the national law and is now also focused in the establishment of a Sanitary Landfill;

**WHEREAS**, there is already a site for the establishment of a Sanitary Landfill which was already approved by the Department of Environment and Natural Resources (DENR);

**WHEREAS**, Barangay Bulaklakan, Narra, Lucio Laurel, G. Antonino, Malamig, San Antonio, Kawit, Banutan and Agsalin supports Barangay Agos as the Lead Barangay in the establishment of Category I Sanitary Landfill located in Barangay Agos, Gloria, Oriental Mindoro;

**WHEREAS**, this body finds the said request to be of merit.


**NOW THEREFORE**, on motion of **Hon. Romeo Edward P. Alvarez, Chairperson**, Committee on Public Works & Infrastructure and was duly seconded by Hon. Felix V. Jarabe III, so be it;

**RESOLVED AS IT IS HEREBY RESOLVED**, that the resolution authorizing the Lead Barangay Agos represented by Hon. Erickson M. Semilla, Barangay Captain to construct Category I Sanitary Landfill in the parcel of lot (Lot E) owned by the Municipal Government of Gloria with Transfer Certificate of Title No. 064-2018005240 with an area of Six (6) Hectares located at Barangay Agos, Gloria, Oriental Mindoro, be approved.

**RESOLVED FURTHER**, that copy of this resolution be furnished the Office of the Municipal Mayor, Office of the Municipal Budget, Office of the Municipal Accountant and Office of the Municipal Environment & Natural Resources Officer, all of Gloria, Province of Oriental Mindoro for their information and guidance.
