**RESOLUTION NO. 2018-194**

**A RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL THROUGH DR. TERESITA G. INCIONG VICE-CHAIRPERSON & EXECUTIVE DIRECTOR FOR THE ESTABLISHMENT OF NATIONAL CHILD DEVELOPMENT CENTERS (NCDC) IN THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated December 7, 2018 requesting to pass a resolution requesting financial assistance from Early Childhood Care and Development (ECCD) Council, through Dr. Teresita G. Inciong, Vice-Chairperson & Executive Director for the establishment of National Child Development Centers (NCDC) in the Municipality of Gloria, Province of Oriental Mindoro;

**WHEREAS**, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

**WHEREAS**, in accordance with the principles of local autonomy and integrated development, there is a need to coordinate national government policies and programs with those of local government units;

**WHEREAS**, there is a need to construct a fully-furnished and fully-equipped National Child Development Centers in the Municipality of Gloria, Province of Oriental Mindoro;

**WHEREAS**, considering the high costs that this project would entail, the municipality has to seek outside financial assistance specifically from the national government;

**WHEREAS**, immediate allocation of the fund prayed for will eventually redound to full range of health, nutrition, early education and social services development programs that provide for the basic holistic needs of young children from age zero (0) to four (4) years; and to promote their optimum growth and development;

**WHEREAS**, this body finds that the said request to be of merit.

**NOW THEREFORE**, on motion of Hon. Norma R. Paz, Chairperson, Committee on Social Services, Women, Children, Family Relation, Elderly and Person with Disability and was jointly seconded by Hon. Felix V. Jarabe III and Hon. Lauro L. De Belen, so be it;

**RESOLVED, AS IT IS HEREBY RESOLVED**, that the resolution requesting financial assistance from Early Childhood Care and Development (ECCD) Council, through Dr. Teresita G. Inciong Vice-Chairperson & Executive Director for the establishment of National Child Development Centers (NCDC) in the Municipality of Gloria, Province of Oriental Mindoro, be approved.
