RESOLUTION NO. 2018-195

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL REPRESENTED BY ITS VICE-CHAIRPERSON & EXECUTIVE DIRECTOR, DR. TERESITA G. INCIONG AND THE MUNICIPALITY OF GLORIA FOR THE ESTABLISHMENT OF NATIONAL CHILD DEVELOPMENT CENTERS IN THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated December 7, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Early Childhood Care and Development (ECCD) Council represented by its Vice-Chairperson & Executive Director, Dr. Teresita G. Inciong and the Municipality of Gloria for the establishment of the National Child Development Centers in the Municipality of Gloria, Province of Oriental Mindoro;

WHEREAS, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, as provided in the Early Years Act, the ECCD Council is mandated to establish National Child Development Center (NCDC's) and convert selected existing Day Care Centers into Child Development Centers (CDC);

WHEREAS, in pursuance of the above mandate, the ECCD Council aims to further enhance the provision of quality home-based and center-based ECCD programs by establishing National Child Development Centers in partnership with local government units;

WHEREAS, this body finds that the said request to be of merit.


NOW THEREFORE, on motion of Hon. Norma R. Paz, Chairperson, Committee on Social Services, Women, Children, Family Relation, Elderly and Person with Disability and was jointly seconded by Hon. Felix V. Jarabe III and Hon. Lauro L. De Belen, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement (MOA) by and between the Early Childhood Care and Development (ECCD) Council represented by its Vice-Chairperson & Executive Director, Dr. Teresita G. Inciong and the Municipality of Gloria for the establishment of the National Child Development Centers in the Municipality of Gloria, Province of Oriental Mindoro, be approved.

RESOLVED FURTHER, that copy of this resolution be furnished Early Childhood Care and Development (ECCD) Council for their information and guidance.
