Hon. Crispin J. Bawasanta read the letter from the Municipal Mayor and the Department of Social Welfare and Development Office (DSWD). He moved to approve the request in the first (1<sup>st</sup>) reading and therefore moved to include it in the second (2<sup>nd</sup>) reading and was duly seconded by all Sangguniang Bayan Members present.

Hon. Nick Orlando M. Jamilla referred the letter to the Chairperson of the Committee on Good Governance, Public Ethics and Accountability.



municipality of Gloria. He said, "This is not an investigation, we will just clarify the statement of Hon. Vice Mayor Ramon G. Solas during the Municipal Inter Barangay Forum (MIBF) held last December 14, 2018." He asked, "Are you amenable to conduct immediate action during this regular session?"

The August Body agreed to have the immediate action regarding the said issue.

Hon. Romeo S. Sadiwa emphasized, "Last Saturday, somebody told me about the pronouncement of our Municipal Vice Mayor and they became sad and disappointed regarding the matter knowing the good image of KALAHI CIDSS in implementing KALAHI Programs. We have to know whether or not the said pronouncement is true."

Hon. Nicandro F. Fabon, Jr. requested the Secretariat to furnish them with the copy of the said letter. He emphasized, "All matters regarding the issue must be clarified for us to know the truth."

Hon. Henry S. Soberano stressed, "The Liga ng mga Barangay is disappointed regarding the pronouncement of our Municipal Vice Mayor. Alam po nating lahat na may isang araw sa isang linggong pagtatrabaho na hindi swenesweldohan ang mga trabahador sa pagawain ng KALAHI bilang tulong ng Barangay sa kanilang proyekto kaya't nakakalungkot na marinig na parang may nangyayari pang katiwalian sa pagpapatupad ng mga proyekto nito. Ni minsan po ay hindi humawak ang Barangay ng pondo mula sa KALAHI sapagkat KALAHI mismo ang nagpapatupad nito. Nakakasigurado po ako na walang anumalya sa part naming mga Kapitan."

Hon. Crispin J. Bawasanta emphasized, "I hope that everything will be clarified regarding this matter, kung ano man, sino man o bakit nagkaroon ng ganito issue ang KALAHI."

Hon. Nick Orlando M. Jamilla stressed, "We all believe that the programs of KALAHI are very successful especially in the way they implemented the project that is why we enact an ordinance adopting KALAHI process and principles. We save funds if the project is being implemented by KALAHI. It undergone proper consultation and in fact we are one of the awardees of KALAHI through the help of Ms. Guevarra. Because of their managerial skills, love and sincerity, KALAHI continues to help our municipality. We are about to receive the Twelve Million Six Hundred Thousand Pesos (P12,600,000.00) from KALAHI that was deliberated last December 14, 2018 but because of the pronouncement of our Municipal Vice Mayor, the DSWD will hold the project. When I saw and heard the reactions of the attendees of the meeting, I felt disappointed also because I don't know how corruption occurred in spite of the very good process being made by KALAHI. He explained the KALAHI process and principles. He emphasized, "No Barangay Officials are involved in the disbursement of money. Saang bahagi nagkaroon ng anumalya? We have to clarify this issue as soon as possible so that the project will not be affected. We are all aiming to have the Sanitary Landfill. He stressed, "Tulungan nyo po kaming linawin ang lahat ng ito. Alam kong galit kayo sa mga nangungurakot. Sabihin nyo po sa amin at sasamahan namin kayo upang maisaayos ang problema."

Hon. Lauro L. De Belen requested the Presiding Officer to provide all the evidences regarding his accusation.

Hon. Nick Orlando M. Jamilla said, "This is not an investigation. We are just asking the help of our Municipal Vice Mayor to clarify all issues regarding the said problem. Kayo po ang nakakaalam nyan at sana po ay tulungan nyo po kami."

Hon. Lauro L. De Belen moved for a recess/break and was jointly seconded by Hon. Crispin J. Bawasanta and Hon. Romeo Edward P. Alvarez.
