





A RESOLUTION APPROVING THE TRANSFER FROM THE GENERAL FUND ACCOUNT TO TRUST FUND ACCOUNT THE AMOUNT OF THREE HUNDRED THIRTY FIVE THOUSAND PESOS ONLY (Php335,000.00) FROM THE 2017 SPECIAL PURPOSE APPROPRIATIONS-AID TO OSCA TO BE ALLOTTED FOR THE HEALTH CARE BENEFITS (HEALTH CARD) TO QUALIFIED SENIOR CITIZENS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated January 29, 2018 requesting to pass a resolution approving the transfer from the General Fund Account to Trust Fund Account the amount of Three Hundred Thirty Five Thousand Pesos only (Php335,000.00) from the 2017 Special Purpose Appropriations-Aid to OSCA to be allotted for the Health Care Benefits (Health Card) to Qualified Senior Citizens;

WHEREAS, the power of the Sangguniang Bayan to pass and enact resolutions and ordinances includes the power to amend and revoke;


