- 3. Ordinansang Pambarangay Blg. 3 Serye 2018 na may pamagat na "KAUTUSANG NAGTATAKDA NG MGA PATAKARAN NANG MAAYOS NA PAGTATAPON NG BASURA ALINSUNOD SA PAMBAYANG ORDINANSA BILANG 05 SERYE 2005 NA KILALA SA TAWAG NA "COMPREHENSIVE SOLID WASTE MANAGEMENT SYSTEM"

WHEREAS, this matter was referred to the Committee on Laws and Ordinances and after a thorough deliberation on the matter and finding all requisites to be in order and not contrary to law and within its power to impose, it is the consensus of the Committee to approve said Barangay Ordinances;

WHEREAS, Article 111 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Panlungsod/Bayan concerned has the authority to review as to whether the ordinance is consistent with the law and city/municipal ordinances;

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991, Article IV, Section 152, (d), the barangay may levy reasonable fees and charges;

WHEREAS, the Committee on Laws and Ordinances, of this august body conducted initial review and evaluation on the documents submitted and found out that the same is in order and enacted within the conferred powers of the Barangay pursuant to paragraph (a) item 1 Art. 101 of the Rules and Regulations Implementing the R.A. 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, Ordinansa Blg. 01, 02, 03 S. 2018 of Barangay Mirayan will increase and improve collection of fees and charges thereby generating more funds to finance various projects, programs and activities of the barangay.

NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Chairperson, Committee on Laws and Ordinances and was duly seconded by Hon. Felix V. Jarabe III, so be it
