

RESOLUTION NO. 2018-203

A RESOLUTION AFFIRMING THAT THE PROJECT ENTITLED "CONSTRUCTIONS OF CHILD DEVELOPMENT CENTER" IS PART OF THE DULY APPROVED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO WITH BUDGET ALLOCATION AMOUNTING TO TWO MILLION AND FORTY THOUSAND (P2,040,000.00) FOR DAY CARE WORKER HONORARIUM AND FIVE THOUSAND PESOS (P5,000.00) FOR BUILDING MAINTENANCE AS LGU COUNTERPART FOR THE AVAILMENT OF THE FUNDING ASSISTANCE FROM THE DEPARTMENT OF SOCIAL WELFARE & DEVELOPMENT OFFICE

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated December 14, 2018 requesting to pass a resolution affirming that the project entitled "Constructions of Child Development Center" is part of the duly approved Annual Investment Program of the Municipality of Gloria, Province of Oriental Mindoro with budget allocation amounting to Two Million and Forty Thousand (P2,040,000.00) for Day Care Worker Honorarium and Five Thousand Pesos (P5,000.00) for building maintenance as LGU counterpart for the availment of the funding assistance from the Department of Social Welfare & Development Office;

WHEREAS, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, after a careful study and understanding of the facts stated therein, the Sangguniang Bayan considering the noble intention of the Municipal Government of Gloria to realize the project entitled "Construction of Child Development Center" for the general welfare of the constituents;

WHEREAS, this body finds that the said request to be of merit.

NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta and was jointly seconded by Hon. Felix V. Jarabe III and Hon. Nicandro F. Fabon, Jr., so be it;
