RESOLUTION NO. 2018-22

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ALLOW THE SANGGUNIANG BARANGAY OF MALIGAYA TO CONSTRUCT BARANGAY HEALTH STATION (BHS) ADJACENT WITH THE BALAY LAKOY IN LIWASANG LAMBINGAN LOCATED IN BARANGAY MALIGAYA, GLORIA, ORIENTAL MINDORO WITH AN AREA OF SEVENTY FIVE (75) SQUARE METERS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter dated February 2, 2018 requesting to pass a resolution authorizing the local chief executive to allow the Sangguniang Barangay of Maligaya to construct Barangay Health Station (BHS) adjacent with the Balay Lakoy in Liwasang Lambingan located in Barangay Maligaya, Gloria, Oriental Mindoro;

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that: Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental of its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of the inhabitants;

WHEREAS, one of the major challenges in the Philippine health sector is providing access to appropriate health facilities for the poor and the marginalized sector of the society;

WHEREAS, the Department of Health pushed to expedite the implementation of the Health Facilities Enhancement Program for the upgrading of health facilities through investments in infrastructure and medical equipment;

WHEREAS, the Construction of Barangay Health Station (BHS) is under the Health Facilities Enhancement Program of the Department of Health which seeks to upgrade the infrastructure and equipment of government health facilities across the country;

WHEREAS, the Construction of Barangay Health Station (BHS) aims to provide suitable facility and more efficient health care services to the constituents of Barangay Maligaya;

WHEREAS, this body finds the said request to be of merit.


NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairperson**, Committee on Laws and Ordinances and duly seconded by Hon. Nick Orlando M. Jamilla, so be it;

RESOLVED AS IT IS HEREBY RESOLVED, that the resolution authorizing the Local Chief Executive to allow the Sangguniang Barangay of Maligaya to construct Barangay Health Station (BHS) adjacent with the Balay Lakoy in Liwasang Lambingan located in Barangay Maligaya, Gloria, Oriental Mindoro with an area of Seventy Five (75) square meters, be approved.

UNANIMOUSLY APPROVED.

RESOLVED FURTHER, that copy of this resolution be furnished the Office of the Municipal Mayor, Office of the Municipal Budget, Office of the Municipal Accountant, Office of the Municipal Health Officer and the Sangguniang Barangay of Maligaya, all of Gloria, Province of Oriental Mindoro for their information and guidance.


