RESOLUTION NO. 2018-30

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO UTILIZE THE 20% DEVELOPMENT FUND CY-2017 CONTINUING FUND APPROPRIATED FOR THE PURCHASE OF RELOCATION LAND FOR THE LANDLESS INDIGENT FAMILIES AMOUNTING TO TWO HUNDRED TWENTY THOUSAND PESOS ONLY (PhP220,000.00) AS COUNTERPART OF THE MUNICIPAL GOVERNMENT OF GLORIA TO BARANGAY MARAGOOC, GLORIA, ORIENTAL MINDORO INTENDED FOR "PABAHAY PROJECT PARA SA MAHIHIRAP"

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated March 1, 2018 requesting to pass a resolution authorizing the local chief executive to utilize the 20% Development Fund CY-2017 Continuing Fund appropriated for the Purchase of relocation land for landless indigent families amounting to Two Hundred Twenty Thousand Pesos (PhP220,000.00) as counterpart of the Municipal Government of Gloria to Barangay Maragooc, Gloria, Oriental Mindoro;

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that: Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental of its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 10 of R.A. No. 8974 states that, "The government shall provide adequate appropriations that will allow the concerned implementing agencies to acquire the required right-of-way, site or location for any national government infrastructure project".

WHEREAS, the Local Finance Committee certify that the amount of Two Hundred Twenty Thousand Pesos (P220,000.00) for Additional Fund for Purchase of Relocation Land has been appropriated, available and allocated in the approved Realignment of Funds through Appropriation Ordinance No. 22 dated August 10, 2017 under the 20% Development Fund of the Office of the Municipal Mayor;

WHEREAS, the Municipal Appraisal Committee (MAC) has negotiated and evaluated a land located in Barangay Maragooc, Gloria, Oriental Mindoro owned by Rolando Mejico married to Purificacion under Tax Declaration No. 2015-060021-00337 and covered and embraced by TCT No. RT-199 (T-37923), containing an area of Ten Thousand (10,000) Square Meters more or less located at Maragooc, Gloria, Oriental Mindoro;

WHEREAS, after the ocular inspection the body has agreed and voted upon the suggested value which is just fair, reasonable and advantageous on the part of the Municipal Government of Gloria and Barangay Maragooc;

WHEREAS, this august body deems it proper to authorize the Municipal Mayor, Hon. German D. Rodegerio to utilize the 20% Development Fund CY 2017 Continuing Fund amounting to Two Hundred Twenty Thousand Pesos (Php220,000.00) as counterpart of the Municipal Government of Gloria for the purchase of relocation land for landless indigent families located at Barangay Maragooc, Gloria, Oriental Mindoro.


NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation** and was jointly seconded by Hon. Nicandro F. Fabon, Jr. and Hon. Lauro L. De Belen, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to utilize the 20% Development Fund CY 2017 Continuing Fund appropriated for the Purchase of Relocation Land for Landless Indigent Families amounting to Two Hundred Twenty Thousand Pesos Only (Php220,000.00) as counterpart of the Municipal Government of Gloria to Barangay Maragooc, Gloria, Oriental Mindoro intended for the Pabahay Project Para sa Mahihirap, be approved.

UNANIMOUSLY APPROVED.
