A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF GLORIA AND THE UCPB SAVINGS BANK, INC. REPRESENTED BY ITS BRANCH BANKING DIVISION HEAD WILFRED D. ABOBO FOR THE AVAILMENT OF PERSONAL LOANS WITH MORTALITY REDEMPTION INSURANCE (MRI) OF QUALIFIED OFFICERS AND PERMANENT EMPLOYEES OF THE LOCAL GOVERNMENT UNIT

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, the Local Government Unit of Gloria requested UCPB Savings Bank Inc. to extend its Personal Loans with Mortality Redemption Insurance (MRI) to qualified officers and employees of the Local Government Unit of Gloria;

WHEREAS, Sangguniang Bayan of Gloria authorized Hon. German D. Rodegerio, Municipal Mayor to enter and sign the Memorandum of Agreement (MOA) with the UCPB Savings Bank Inc. Payroll Service Plan Loan (PSPL-Non DepEd) Program for the availment of Personal Loans with Mortality Redemption Insurance (MRI) of qualified officials and employees;

WHEREAS, UCPB Savings Bank Inc. has agreed to the Local Government Unit (LGU) of Gloria request subject to such terms and conditions as may be mutually agreed upon.

NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation and was duly seconded by Hon. Romeo S. Sadiwa, so be it;
