LARGA TO OPEN A TWO (2) NEW BANK ACCOUNTS AT THE LANDBANK OF THE PHILIPPINES-PINAMALAYAN BRANCH, PINAMALAYAN, ORIENTAL MINDORO INTENDED FOR 20% DEVELOPMENT FUND AND 5% DISASTER RISK REDUCTION MANAGEMENT FUND

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated March 8, 2018 requesting to authorize the Local Chief Executive and the Municipal Treasurer to open two (2) new bank accounts intended for 20% Development Fund and 5% DRRM Fund;




