







**RESOLUTION NO. 2018-39**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE ENVIRONMENTAL MANAGEMENT BUREAU-DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (EMB-DENR) REPRESENTED BY ITS OIC-REGIONAL DIRECTOR MARIA SOCORRO A. ABU FOR THE PROVISION OF TECHNICAL AND FINANCIAL ASSISTANCE FOR THE ESTABLISHMENT AND OPERATION OF MATERIAL RECOVERY FACILITY WITH MOBILE SHREDDER FOR CALENDAR YEAR 2018

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated March 16, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement by and between the Municipal Government of Gloria and the Environmental Management Bureau-Department of Environment and Natural Resources (EMBoDENR) represented by its OIC-Regional Director Maria Socorro A. Abu for the provision of Technical and Financial Assistance for the establishment and operation of Material Recovery Facility with Mobile Shredder for Calendar Year 2018;

**WHEREAS**, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

**WHEREAS**, Section 32 of RA 9003 states that the local government units shall share the responsibility in the ecological management of materials toward waste diversion within their territorial jurisdiction;

**WHEREAS**, for the furtherance of the objectives of RA 9003, the DENR shall establish methods and other parameters for the measurement of waste reduction, collection and disposal;

**WHEREAS**, the body finds that the said request to be of merit.


**NOW THEREFORE**, on motion of **Hon. Romeo S. Sadiwa, Vice Chairperson**, Committee on Environmental Protection, Natural Resources and Ecology and was duly seconded by seconded by Hon. Lauro L. De Belen, so be it.

**RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) with the Environmental Management Bureau-Department of Environment and Natural Resources (EMB-DENR), be approved.
