



RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO AND THE MUNICIPAL TREASURER, MRS. MERLITA M. LARGA TO OPEN THREE (3) NEW CURRENT ACCOUNTS AT THE LANDBANK OF THE PHILIPPINES-PINAMALAYAN BRANCH, PINAMALAYAN, ORIENTAL MINDORO INTENDED FOR THE MARKET, SLAUGHTERHOUSE AND CEMETERY

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated March 16, 2018 requesting to authorize the Local Chief Executive and the Municipal Treasurer to open three (3) new current accounts intended for the Market, Slaughterhouse and Cemetery;

WHEREAS, the Treasurer shall take charge of the Treasury Office; perform the duties provided under Book II of the Local Government Code of 1991; take custody and exercise proper management of funds of LGU;

WHEREAS, the three (3) new current accounts will be used for proper accounting and monitoring of the LGU's financial operations and in preparation of setting up local economic enterprise;

WHEREAS, PD #1445, Section 65 Par 2 states that, "Amounts received in trust and from business-type activities of government may be separately recorded and disbursed in accordance with such rules and regulations;

WHEREAS, this resolution will remain effective until it is hereby repealed, amended and modified accordingly.

NOW THEREFORE, on motion of Hon. Norma R. Paz, Chairperson, Committee on Ways and Means and was duly seconded by Hon. Lauro L. De Belen, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor and the Municipal Treasurer to open three (3) New Current Accounts at the Landbank of the Philippines-Pinamalayan Branch, Pinamalayan, Oriental Mindoro, intended for the Market, Slaughterhouse and Cemetery, be approved.


