RESOLUTION NO. 2018-42

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A COLLECTION AND REMITTANCE AGREEMENT (CRA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) REPRESENTED BY ITS REGIONAL VICE PRESIDENT, PAOLO JOHANN C. PEREZ

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 2, 2018 requesting for the review and approval of the Collection and Remittance Agreement (CRA) from Philippine Health Insurance Corporation (PHILHEALTH) Regional Office IV-B in line with the initial accreditation and remittance agreement and the contract of agreement of LGU Gloria;

WHEREAS, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, PHILHEALTH has accredited LGU-Gloria, Oriental Mindoro which shall provide the collection-remittance service;

WHEREAS, to make the remittances to PHILHEALTH more convenient to the paying members/individuals and employees, PHILHEALTH needs to engage the services of LGU-Gloria, Oriental Mindoro to collect and receive the NHIP premium contribution as one of its collecting agents;

WHEREAS, the body finds that the said request to be of merit.

NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairperson**, Committee on Finance and Appropriation and was jointly seconded by Hon. Lauro L. De Belen and Hon. Norma R. Paz, so be it.

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Local Chief Executive to enter and sign into a Collection and Remittance Agreement (CRA) by and between the Municipality of Gloria and the Philippine Health Insurance Corporation (PHILHEALTH) represented by its Regional Vice President, Paolo Johann C. Perez, be approved.

UNANIMOUSLY APPROVED.

RESOLVED FURTHER, that copy of this resolution be furnished the Philippine Health Insurance Corporation (PHILHEALTH), Office of the Municipal Mayor, Office of the Municipal Treasurer, Office of the Municipal Budget Officer and Office of the Municipal Accountant for their information and guidance.


