**RESOLUTION NO. 2018-44**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE PHILIPPINE COCONUT AUTHORITY (PCA) REPRESENTED BY ITS ADMINISTRATOR, ROMULO J. DELA ROSA FOR THE IMPLEMENTATION OF THE KANIB COCO HUB PROJECT (KCHP)**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated April 5, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement by and between the Municipal Government of Gloria and the Philippine Coconut Authority (PCA) represented by its Administrator, Romulo J. Dela Rosa for the implementation of the Kaanib Coco Hub Project (KCHP)

**WHEREAS**, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

**WHEREAS**, Kaanib Coco Hub Project (KCHP) is defined as a strategic partnership and productive alliances between PCA and coconut farmer's organization or cooperatives, local government units (LGUs), and social business enterprises among others;

**WHEREAS**, empowerment of coconut farmers is vital to transform them into enterprising groups in the communities to create jobs and increase their income;

**WHEREAS**, the LGU has expressed interest to implement the KCHP through the establishment and management of Virgin Coconut Oil (VCO) Processing Plant to enhance utilization of coconut products and by-products, increase income of the coconut farmers and generate more jobs and develop rural employment;

**WHEREAS**, the LGU, fully supportive of the improvements of the standard of living of coconut farmers with full confidence in the viability and profitability of the business agrees to comply with the new requirement and to continue its participation in the project;

**WHEREAS**, the body finds that the said request to be of merit.

**NOW THEREFORE**, on motion of **Hon. Romeo S. Sadiwa, Chairperson**, Committee on Agriculture and Aquatic Resources and was duly seconded by Hon. Felix V. Jarabe III, so be it.

**RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) with the Philippine Coconut Authority (PCA), be approved.


