



**RESOLUTION NO. 2018-48**

**A RESOLUTION EXTENDING OUR SINCERE APPRECIATION AND COMMENDATION TO FR. DENNIS MARCELO M. DELMO III, SACRED HEART PARISH PRIEST FOR HIS INVALUABLE CONTRIBUTIONS FOR MOLDING THE SPIRITUAL AND MORAL LIFE OF THE GLORIANOS FOR SIX (6) YEARS**

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III have served the Lord with gladness, tirelessly, faithfully and with great compassion for His flocks;

**WHEREAS**, St. Paul writes to “remind” the Romans, i.e., to make something present to them. In so many ways, priesthood is about presence. On the one hand, there is the mysterious and profound grace by which the priest makes Christ present — really present — at the church’s Eucharist. On the other hand, the value of the ordinary day-today presence of the priest cannot be overestimated;

**WHEREAS**, “a teacher affects eternity; he can never tell where his influence stops.”<sup>2</sup> How much more true is this for the parish priest! Just as small children get their first ideas about what God is like from their parents, so too can parishioners’ images of God be influenced by encounters with their priests;

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III who is welcoming, who is available, who is dependable, who is trustworthy, who is joyful — a priest who knows he is loved by God and who radiates that love in his presence and demeanor — such a priest can bring the light of Christ and the consolation of the Holy Spirit into the darkest corners of human suffering though his gentle and steady presence;

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III doesn’t “wish” to be first; rather, he experiences Christ’s call to follow Him in this unique way, and in answering that call he is called to live, to work, to stand — to be present — in the person of Christ. He doesn’t “stand in” for Christ; by his presence, he makes Christ present. Far from giving him a “lofty” self image, this “priestly service of the gospel of God” requires selflessness, humility and an ever-increasing intimacy with Christ;

**WHEREAS**, the Municipality of Gloria has been fortunate to have a dedicated priest committed to the mission of shaping and molding spiritual care to individuals, families and communities;

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III unselfishly shared his knowledge and dedicated his time and effort to share the life of Jesus;

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III has been a consistent, industrious, competent and sincerely dedicated his life to serve as Parish Priest and Director of Sacred Heart Academy;

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III is an instrument in strengthening the relationship between the church and the state particularly with the Local Government Unit of Gloria;

**WHEREAS**, Fr. Dennis Marcelo M. Delmo III had served the parish in a commendable fashion; he is truly a fine person and a good example in demonstrating the character of a Priest;
