**RESOLUTION NO. 2018-53**

**A RESOLUTION APPROVING THE RE-ACCREDITATION OF THE GLORIA SUSTAINABLE AGRICULTURE ASSOCIATION (GLOSAA) AS NON-GOVERNMENTAL ORGANIZATION (NGO) IN THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated April 4, 2018 requesting to pass a resolution approving the re-accreditation of the Gloria Sustainable Agriculture Association (GLOSAA) represented by its President, Ms. Cleofe Minay Atienza as Non-Governmental Organization (NGO);

**WHEREAS**, Rule XIII, Article 64 of the Implementing Rules and Regulations (IRR) of the Local Government Code of 1991 provides that NGOs, POs and Private Sector (PS) Organizations must apply with the Local Government Unit for accreditation for membership in the Local Special Bodies;

**WHEREAS**, Section 34 of the Local Government Code of 1991 and its Implementing Rules & Regulations provides that, to become active partners in the pursuit of local autonomy, LGUs are mandated to promote the establishment and operation of people's and non-governmental organizations;

**WHEREAS**, Article II, Section 23 of the Philippine Constitution provides that the state shall encourage non-government, community-based, or sectoral organizations that promote the welfare of the nation;

**WHEREAS**, Section 16, Article XIII of the 1987 Constitution states that "the right of the people and their organizations to effective and reasonable participation at all levels of social, political, and economic decision-making shall not be abridged. The State shall, by law, facilitate the establishment of adequate consultation mechanisms;


