

**RESOLUTION NO. 2018-58**

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO IN BEHALF OF THE LOCAL GOVERNMENT OF GLORIA TO SIGN THE DEED OF DONATION WITH THE DEPARTMENT OF HEALTH-REGIONAL OFFICE MIMAROPA REPRESENTED BY EDUARDO C. JANAIRRO, M.D., MPH, CESO III, DIRECTOR IV FOR THE ACCEPTANCE OF PORTABLE ULTRASOUND MACHINE AND ANDROID TABLET**

**WHEREAS**, letter dated April 19, 2018 from Honorable Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable Mayor to enter the Deed of Donation of Portable Ultrasound Machine and Android Tablet from the Department of Health-Regional Health Office-IV-MIMAROPA;

**WHEREAS**, the DOH issued the Department Order Memorandum No. 2017-0264 dated June 29, 2017 to execute Deed of Donation for Portable Ultrasound Equipment;
