

RESOLUTION NO. 2018-60

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE, MIMAROPA REPRESENTED BY ITS REGIONAL DIRECTOR, ANTONIO G. GERUNDIO, CESO III, DPA AND THE MUNICIPALITY OF GLORIA FOR THE IMPLEMENTATION OF THE PROJECT ENTITLED "ESTABLISHMENT OF SUSTAINABLE SWINE MULTIPLIER FARM".

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated May 10, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Department of Agriculture, MIMAROPA represented by its Regional Director, Antonio G. Gerundio, CESO III, DPA for the implementation of the project entitled "Establishment of Sustainable Swine Multiplier Farm";

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, the Department of Agriculture, MIMAROPA is one of the implementing agencies that is tasked to coordinate the implementation of different agricultural and livestock development and livelihood programs and projects in the field level;

WHEREAS, the body finds that the said request to be of merit.

NOW THEREFORE, on motion of **Hon. Romeo S. Sadiwa, Chairperson**, Committee on Agriculture and Aquatic Resources and was duly seconded by Hon. Felix V. Jarabe III, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) with the Department of Agriculture, MIMAROPA represented by its Regional Director, Antonio G. Gerundio, CESO III, DPA for the implementation of the project entitled "Establishment of Sustainable Swine Multiplier Farm", be approved.
