RESOLUTION NO. 2018-61

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A SPECIFIC IMPLEMENTATION AGREEMENT (SIA) BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY WILMA D. NAVIAMOS IN HER CAPACITY AS REGIONAL DIRECTOR OF FIELD OFFICE REGION IV-B, AND THE MUNICIPALITY OF GLORIA, ORIENTAL MINDORO FOR THE IMPLEMENTATION OF THE DSWD'S SUSTAINABLE LIVELIHOOD PROGRAM (SPL)

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated May 7, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Specific Implementation Agreement (SIA) by and between the Department of Social Welfare and Development (DSWD), represented by Wilma D. Naviamos in her capacity as Regional Director of Field Office Region IV-B and the Municipality of Gloria, Oriental Mindoro for the implementation of the DSWD's Sustainable Livelihood Program (SPL);

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, Section 22 R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, the partnership between the Municipality of Gloria, Province of Oriental Mindoro and the DSWD is necessary in the realization and success in the implementation of the Sustainable Livelihood Program (SPL);

WHEREAS, the Sustainable Livelihood Program (SPL) is an innovative approach to livelihood development and people empowerment;

WHEREAS, this body finds the said request to be of merit.

NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Vice Chairperson, Committee on Social Services, Women, Children, Family Relation, Elderly & Indigenous People and was duly seconded by Hon. Felix V. Jarabe III, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D.
