

RESOLUTION NO. 2018-64

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE ERHARD SCIENCE AND TECHNOLOGICAL INSTITUTE (ESTI) REPRESENTED BY ITS ADMINISTRATOR, MRS. CECILIA F. YUMANG FOR THE IMPLEMENTATION OF THE ON THE JOB TRAINING OF 3RD YEAR BACHELOR OF SCIENCE IN COMPUTER SCIENCE STUDENTS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated April 19, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the Erhard Science and Technological Institute (ESTI) represented by its Administrator, Mrs. Cecilia F. Yumang for the implementation of the On the Job Training of 3rd year Bachelor of Science in Computer Science students;

WHEREAS, Section 22 R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, Erhard Science and Technological Institute requested to accommodate the four (4) Bachelor of Science in Computer Science practicum students: Mascariñas, Jonel D.; Mayamaya, Sharmaine Q.; Ondoy, John Cristopher S.; and Quintana, Janine L;

WHEREAS, the said program is in compliance with the curriculum requirements for graduation in the course Bachelor of Science in Computer Science where in the students are required to undergo 180 hours of actual hands on training;

WHEREAS, the On the Job Training will start on May 21, 2018;

WHEREAS, Mr. Jamael G. Bantog, ESTI Computer Science Instructor is the authorized representative of the school to monitor and evaluate the performance of the students;

WHEREAS, the trainees shall abide to the existing rules and regulations of the Local Government Unit under RA 7160 provisions on Human Resource and Development;

WHEREAS, either party may discontinue the training of any students on reasonable grounds as stated in the Memorandum of Agreement observing the due process of law;

WHEREAS, it is expressly understood by both PARTIES that the AGENCY is not obliged to pay wages or salaries as expressly implied in the MOA;

WHEREAS, the body finds that the request to be of merit.

NOW THEREFORE, on motion of **Hon. Eleuterio H. Roldan, Vice Chairperson**, Committee on Education, Culture and Arts and was duly seconded by Hon. Felix V. Jarabe III, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the Erhard Science and Technological Institute (ESTI) represented by its Administrator, Mrs. Cecilia F. Yumang for the implementation of the On the Job Training of 3rd year Bachelor of Science in Computer Science students, be approved.
