

**RESOLUTION NO. 2018-65**

**A RESOLUTION APPROVING THE ANNUAL BUDGET FOR CY 2018 OF BARANGAY MALAYONG APPROPRIATING THE AMOUNT OF ONE MILLION, EIGHT HUNDRED TWO THOUSAND PESOS ONLY (Php1,802,000.00) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 001 DATED JANUARY 10, 2018**

**WHEREAS**, letter from the Municipal Budget Officer dated April 18, 2018, submitted to this august body, the Annual Budget for CY 2018 of Barangay Malayong, this municipality, for approval;

**WHEREAS**, the review of the forgoing Annual Budget, 20% Development Plan and 5% BDRRMF Plan of the afore-mentioned barangays likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, issuances, rules and regulations relative thereto;

**WHEREAS**, Sub-section (a) of Sec. 333 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that: Review of the Barangay Budget. -within ten (10) days from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished the Sangguniang Bayan, through the Municipal Budget Officer;

**WHEREAS**, the above cited provision stipulated for the Sanggunian to have the power to review such ordinance in order to ensure that the provisions of R.A. 7160, are complied with;

**WHEREAS**, the budget for CY 2018 of the above-mentioned barangay of this municipality, had been presented for review and appropriate action, after having been deliberated the said budget was found to have complied with the budgetary requirements set forth in R.A. 7160 by the Committee on Finance & Appropriations;

**WHEREAS**, the utilization of the Annual Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace.


**NOW THEREFORE**, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation** and was duly seconded by Hon. Eleuterio H. Roldan, so be it;

**RESOLVED AS IT IS HEREBY RESOLVED**, that the resolution approving the Annual Budget for CY 2018 of Barangay Malayong, be approved.
