RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO IN BEHALF OF THE MUNICIPAL GOVERNMENT OF GLORIA TO ACCEPT THE DONATION MADE BY THE SURVIVING HEIRS OF THE LATE PANTALEON MINAY AND FRANCISCA JABAT REPRESENTED BY THE DULY DESIGNATED ADMINISTRATOR, CLEOFE M. ATIENZA A PORTION OF SIX THOUSAND (6,000) SQ. M. COVERED AND EMBRACED BY LOT 572-K-4 LOCATED AT BARANGAY BALETE, GLORIA, ORIENTAL MINDORO INTENDED FOR THE IMPLEMENTATION OF THE KANIB COCO HUB PROJECT (KCHP)






