## **RESOLUTION NO. 2018-75**

**SAMAHAN** NG ORDERING THE RESOLUTION MAGMAMAIS SA KATIMUGANG MINDORO (SAMAKAMI) MUNICIPAL **TERMINAL** FOOD VACATE THE (FORMERLY BAGSAKAN CENTER) OWNED BY THE LOCAL **PROVINCE** UNIT OF GLORIA, GOVERNMENT ORIENTAL MINDORO

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated May 30, 2018 requesting to pass a resolution informing the Samahan ng Magmamais sa Katimugang Mindoro (SAMAKAMI) to vacate the Municipal Food Terminal (formerly Bagsakan Center);

WHEREAS, Section 444, (2) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that the Sangguniang Bayan as the legislative body prescribe the reasonable limits and restraints on the use of property within the jurisdiction of the municipality;

WHEREAS, it is the concern of the present administration that government properties shall be used for the benefits of the constituents especially on matters that they may otherwise utilized by the municipal government for its public facilities as agreed in the Memorandum of Agreement by and between the Municipality of Gloria and Department of Agriculture;

WHEREAS, the Bagsakan Center creates to ensure that the operation of the project is fully and properly implemented;

WHEREAS, the Bagsakan Center and Barangay Bagsakan Project was implemented to make food accessible to the consumers and link the production area to the market outlets;

**WHEREAS**, the Samahan ng Magmamais sa Katimugang Mindoro (SAMAKAMI) has fifteen (15) days grace period to vacate the Municipal Food Terminal (formerly Bagsakan Center) upon receipt of this resolution; .

*WHEREAS*, this body finds that the said request to be of merit.

**NOW THEREFORE,** on motion of Hon. Nicandro F. Fabon, Jr., Chairperson, Committee on Cooperatives, NGOs and POs and was duly seconded by Hon. Crispin J. Bawasanta, so be it;

**RESOLVED, AS IS IT HEREBY RESOLVED**, that the resolution ordering the Samahan ng Magmamais sa Katimugang Mindoro (SAMAKAMI) to vacate the Municipal Food Terminal (formerly Bagsakan Center) owned by the Local Government Unit of Gloria, Province of Oriental Mindoro, be approved.
