RESOLUTION NO. 2018-75

RESOLUTION ADOPTING REPUBLIC ACT NO. 9147 ENTITLED "AN ACT PROVIDING FOR THE CONSERVATION AND PROTECTION OF WILDLIFE RESOURCES AND THEIR HABITATS, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

WHEREAS, this act shall be known as the "Wildlife Resources Conservation and Protection Act."

WHEREAS, in July 2001, Republic Act No. 9147 otherwise known as An act Providing for the Conservation and Protection of Wildlife Resources and their Habitats, Appropriating Funds therefor and for other purposes, was enacted;

WHEREAS, this law declares it to be the policy of the State to conserve the country's wildlife resources and their habitats for sustainability. And in the pursuit of this policy, such law have the following objectives: (a) to conserve and protect wildlife species and their habitats to promote ecological balance and enhance biological diversity; (b) to regulate the collection and trade of wildlife; (c) to pursue, with due regard to the national interest, the Philippine commitment to international conventions, protection of wildlife and their habitats; and (d) to initiate or support scientific studies on the conservation of biological diversity;

NOW THEREFORE, on motion of Hon. Felix V. Jarabe III, Chairperson, Committee on Environmental Protection, Natural Resources and Ecology and was duly seconded by Hon. Romeo S. Sadiwa, so be it;

RESOLVED, AS IS IT HEREBY RESOLVED that the resolution adopting Republic Act No. 9147 entitled "AN ACT PROVIDING FOR THE CONSERVATION AND PROTECTION OF WILDLIFE RESOURCES AND THEIR HABITATS, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES, be approved.

UNANIMOUSLY APPROVED.

RESOLVED FURTHER, that copy of this resolution be furnished the Office of the Municipal Mayor and the Office of the Municipal Environment and Natural Resources Officer for their information and guidance.
