





RESOLUTION NO. 2018-76

A RESOLUTION FAVORABLY ENDORSING THE PROJECT ENTITLED, "CONCRETING OF VARIOUS ROAD" AND AFFIRMING THAT THE PROJECT IS PART OF THE DULY APPROVED 2017-2019 LOCAL DEVELOPMENT INVESTMENT PROGRAM AND 2018 REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated May 30, 2018 requesting to pass a resolution endorsing the project entitled "Concreting of Various Road" and affirming that the project is part of the duly approved Local Development Investment Program and Annual Investment Program as one of the requirements for the availment of financial assistance;

WHEREAS, the Department of Budget and Management recently released the Local Budget Circular No. 117 dated February 5, 2018 regarding the guidelines on the release and utilization of the Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the FY 2018 General Appropriations Act (GAA), Republic Act (RA) No. 10964;

WHEREAS, Section 17(3) of the Local Government Code mandates the LGU to exercise power and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective governance such as providing their constituents the basic services and facilities;

WHEREAS, considering the imperative need, to provide adequate and passable road linking among various barangays toward delivery of basic services and road network to develop tourism program as self-generating income;

WHEREAS, such linkages will eventually extend accessibility to farm modernization, hence shipment will be much easier and adequate mobility and transportation of products will become viable in the achievement of sustainable income to progress and development;

WHEREAS, immediate allocation of the fund prayed for will eventually redound not only to the benefit of the barangay concerned in particular, but to the municipality itself in general;

WHEREAS, after a careful study and understanding of the facts stated therein, thus considering the noble intention of the Municipal Government of Gloria to realize the project entitled "Concreting of Various Road" for the general welfare of the constituents;

WHEREAS, this body finds that the said request to be of merit.


NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation and was jointly seconded by Hon. Lauro L. De Belen and Hon. Nicandro F. Fabon, Jr., so be it;
