### RESOLUTION NO. 2018-79

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A SUB-PROJECT AGREEMENT (SPA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE BARANGAY AGOS REPRESENTED BY ITS PUNONG BARANGAY, ERICKSON M. SEMILLA AND BY NYMPHA M. PERILLA, THE BARANGAY SUB-PROJECT MANAGEMENT COMMITTEE CHAIRPERSON FOR THE IMPLEMENTATION OF THE PROJECT "CONSTRUCTION OF EVACUATION CENTER CUM MULTI-PURPOSE HALL".

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated June 1, 2018 requesting to pass a resolution authorizing the local chief executive, Hon. German D. Rodegerio to enter and sign into A Sub-Project Agreement (MOA) by and between the Municipality of Gloria and the Barangay Agos represented by its Punong Barangay, Erickson M. Semilla for the implementation of the project "Construction Of Evacuation Center Cum Multi-Purpose Hall";

WHEREAS, the Sub-Project Agreement to be entered into by and among the Local Government Unit of Gloria, represented by the Municipal Mayor and the Barangay Agos represented by its Punong Barangay, Erickson M. Semilla defines the terms and conditions for the implementation of the project "Construction of Evacuation Center Cum Multi-Purpose Hall";

**WHEREAS**, the joint effort of the abovementioned government agencies will be highly beneficial to the constituents of the barangay in as much as the said undertaking will boosts the moral and improve the quality of life of grass root level;

WHEREAS, the project is jointly funded, among others, grant from the Municipality of Gloria and Barangay Agos intended as Seed Capital for Community Development sub-projects;
