**WHEREAS**, Sub-section (a) of Sec. 333 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that: Review of the Barangay Budget. - within ten (10) days from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished the Sangguniang Bayan, through the Municipal Budget Officer;






