



RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE INFOSHARE MANAGEMENT SYSTEMS REPRESENTED BY ITS CEO, IMELDA C. PANGGA AND THE MUNICIPALITY OF GLORIA FOR THE IMPLEMENTATION OF THE IDENTIFIED PROJECT "CONSULTING SERVICES FOR THE FORMULATION OF CLIMATE CHANGE RESPONSIVE SANITARY LANDFILL FOR THE MUNICIPALITY OF GLORIA, ORIENTAL MINDORO

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated June 18, 2018 requesting to pass a resolution authorizing the local chief executive, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement by and between the Infoshare Management Systems represented by its CEO, Imelda C. Pangga and the Municipal Government of Gloria for the implementation of the identified project "Consulting Services for the formulation of Climate Change Responsive Sanitary Landfill for the Municipality of Gloria, Oriental Mindoro";

WHEREAS, this Sanggunian finds this MOA in order, pursuant to the provisions of Section 444, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance;

WHEREAS, the Municipality of Gloria aims to establish a centralized and effective waste management program and sanitary landfill with due emphasis on abatement of climate change and its effects in the communities and the municipality as a whole;

WHEREAS, the Municipality of Gloria, Oriental Mindoro has the need to prepare the Feasibility Study, Environmental Impact Study and Detailed Engineering Design for Sanitary Landfill for the municipality;

WHEREAS, the goal of this project is to provide an environment-friendly and sustainable garbage disposal facility by constructing a sanitary landfill to cater to the waste management requirements of the municipality in compliance to the mandate imposed by Republic Act 9003 on local government units;

WHEREAS, the proposed sanitary landfill will comply with all environmental regulations required by the Department of Environment and Natural Resources as well as construction regulations prescribed by the Department of Public Works and Highways to abate possible risks and hazards that may be caused by the project

WHEREAS, upon thorough review of the terms and conditions of the Memorandum of Agreement (MOA) the same are found to be in order.


