RESOLUTION NO. 2018-90

RESOLUTION ADOPTING REPUBLIC ACT NO. 10654 OTHERWISE KNOWN AS "AN ACT TO PREVENT, DETER AND ELIMINATE ILLEGAL, UNREPORTED AND UNREGULATED FISHING, AMENDING REPUBLIC ACT NO. 8550 OTHERWISE KNOWN AS "THE PHILIPPINE FISHERIES CODE OF 1998" AND FOR OTHER PURPOSES

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated June 25, 2018 requesting to pass a resolution adopting Republic Act No. 10654 otherwise known as "AN ACT TO PREVENT, DETER AND ELIMINATE ILLEGAL, UNREPORTED AND UNREGULATED FISHING, AMENDING REPUBLIC ACT NO. 8550 OTHERWISE KNOWN AS "THE PHILIPPINE FISHERIES CODE OF 1998" AND FOR OTHER PURPOSES;


WHEREAS, the Management of Fishery and Aquatic Resources in a manner consistent with the concept of an ecosystem-based approach is necessary to protect and conserve our fishery resources and our environment as a whole;

WHEREAS, adopting R.A. 10654 is necessary to ensure the rational and sustainable development, management and conservation of the fishery; and aquatic resources in Philippine waters including the Exclusive Economic Zone (EEZ) and in the adjacent high seas, consistent with the primordial objective of maintaining a sound ecological balance, protecting and enhancing the quality of the environment;

WHEREAS, Republic Act 10654, which amended the Philippine Fisheries Code, lapsed into law on February 27, 2015. It seeks to "prevent, deter and eliminate illegal, unreported and unregulated fishing or IUUF in the country.

WHEREAS, Republic Act No. 7160, otherwise known as The Local Government Code of 1991, Section 447 (a), 1(VI), which provides for the authority of the Sangguniang Bayan to protect the environment and impose appropriate penalties for acts which endanger the environment such as dynamite fishing and other forms of destructive fishing, acceleration of eutrophication of rivers and lake;


