

RESOLUTION NO. 2018-95

RESOLUTION APPROVING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN FOR CY 2018-2022 OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, presented for consideration of this august body was the proposed Municipal Disaster Risk Reduction and Management Plan for CY 2018-2022 of the Municipality of Gloria, Province of Oriental Mindoro;

WHEREAS, pursuant to Republic Act 10121 IRR Rule 6 Section 4 (7) the Municipal Disaster Risk Reduction Management Council in coordination with its Action Officer, is mandated to formulate and implement a comprehensive and integrated LDRRM Plan in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in closed coordination with the municipal development council;

WHEREAS, it is the primary power, duty and function of the Sangguniang Bayan as the legislative body of the municipality, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, the Municipal Disaster Risk Reduction Management Council of the Local Government Unit of Gloria is mandated to prepare the MDRRM Plan incorporating therein programs, projects and activities that will address the LGU's preparedness, response, rehabilitation and recovery, prevention and mitigation concerns relative to disasters or calamities;

WHEREAS, in this participatory planning workshop, operational skills and capacities to implement strategies are taken up in order to lessen the adverse impacts of hazards and the possibility of disaster;

WHEREAS, pre-disaster actions and measures being incorporated in the plan through systematic efforts to analyze and manage the causal factors of disaster;

WHEREAS, in this 5-Year MDRRM Plan, is a consolidated BDRRM Plans of the 27 barangays of this municipality;

WHEREAS, the said plan was referred to the Sangguniang Bayan Committee on Environmental Protection, Natural Resources and Ecology for study and recommendations;

WHEREAS, the Committee on Environmental Protection, Natural Resources and Ecology, recommended the same for approval, after consultation with Municipal Disaster Risk Reduction Management Council.




