RESOLUTION NO. 2018-96

RESOLUTION APPROVING THE 2019-2021 LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) AND CY 2019 ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, the Local Chief Executive through a letter received on June 25, 2018 submitted for review, comment and approval of the 2019-2021 Local Development Investment Program (LDIP) and the CY 2019 Annual Investment Program of the Municipality of Gloria, Province of Oriental Mindoro;

WHEREAS, the Municipal Development Council is mandated to: formulate long-term, medium-term, and annual socio-economic development plans and policies; formulate the medium-term and annual public investment programs; appraise and prioritize socio-economic development programs and projects; and formulate local investments incentives to promote the inflow and direction of private investment capital as provided by Section 109 of the Local Government Code of the Philippines;

WHEREAS, the members of the Municipal Development Council of the Municipality of Gloria had convened and formulated the 2019 Annual Investment Program (AIP) and the 2019-2021 Local Development Investment Program (LDIP) on June 1, 2018 held at the Municipal Conference Hall;

WHEREAS, the formulation of the 2019 Annual Investment Program (AIP) and the 2019-2021 Local Development Investment Program (LDIP) is a good governance practice of transparency and an optimum utilization of scarce public resources;

WHEREAS, the Local Government Code mandates local government units to prepare a Local Development Investment Program, that outlines the key aspirations, challenges and concerns facing the LGUs and a set of programs, projects and policies towards the unstained socio-economic development;

WHEREAS, without the AIP no program/projects can be funded even if the same are included in the Annual Budget;

WHEREAS, the Annual Investment Program (AIP) and the Local Development Investment Program (LDIP) were in conformity with the provisions of the Joint Circular issued by the Department of Budget and Management (DBM) and Department of Interior and Local Government (DILG);

WHEREAS, it is mandated by law to approve the Annual Investment Program (AIP) and the 2019-2021 Local Development Investment Program (LDIP) of the Local Government of Gloria for the socio-economic sustainability;

WHEREAS, the Annual Investment Program and the Local Development Investment Program (LDIP) are the municipality's guide on its development efforts for the following years and are instrumental in achieving the municipality's strategic vision as the Primary Agricultural Production and Eco-Tourism Center in Southern Oriental Mindoro;

WHEREAS, upon careful study on the said proposals, the same had been found to be in order and that the plans, programs and projects contained therein are in consonance with the Priority Agenda of the Municipal Government Administration.

WHEREAS, this body finds the said request to be of merit.


