

**RESOLUTION NO. 2018-97**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE MUNICIPALITY OF GLORIA, THE NATIONAL POLICE COMMISSION REPRESENTED BY ITS ACTING REGIONAL DIRECTOR, ATTY. OWEN DE LUNA AND THE GLORIA MUNICIPAL POLICE STATION REPRESENTED BY ITS CHIEF OF POLICE, PCI REYNALDO C. DOMELOD CENTERED ON COMMUNITY AND SERVICE-ORIENTED POLICING (CSOP), AS PART OF THE LINED-UP ACTIVITIES OF THE 23<sup>RD</sup> PCR MONTH**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated June 27, 2018 requesting to pass a resolution authorizing the local chief executive, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement by and between the Municipality of Gloria, the National Police Commission represented by its Acting Regional Director, Atty. Owen De Luna and the Gloria Municipal Police Station represented by its Chief of Police, PCI Reynaldo C. Domelod Centered on Community and Service-Oriented Policing (CSOP), as part of the lined-up activities of the 23<sup>rd</sup> PCR Month;

**WHEREAS**, this Sanggunian finds this MOA in order, pursuant to the provisions of Section 444, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance;

**WHEREAS**, Section 64 of Republic Act No. 8551 also provides that the Governors and Mayors, upon having been elected and having qualified as such, are automatically "deputized as representatives of the NAPOLCOM in their respective jurisdiction"

**WHEREAS**, the Municipal Government of Gloria has been focused on systems improvement through different programs including OPLAN SAKLOLO, Ugnayan sa Barangay, Anti-illegal drugs campaign, OPLAN Sita and Bantay Kalikasan;



**WHEREAS**, the Community and Service-Oriented Policing framework bolsters coordination and cooperation among the citizenry, local executive and the integrated law enforcement and public safety agencies existing in the locality undertaken through program or project complementation, including sharing of information, funds, personnel and logistics;

**WHEREAS**, upon thorough review of the terms and conditions of the Memorandum of Agreement (MOA) the same are found to be in order.


**NOW THEREFORE**, on motion of **Hon. Felix V. Jarabe III, Chairperson**, Committee on Peace and Order and was duly seconded by Hon. Crispin J. Bawasanta, so be it;

**RESOLVED, AS IT IS HEREBY RESOLVED**, that the resolution authorizing the Local Chief Executive, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement by and between the Municipality of Gloria, the National Police Commission represented by its Acting Regional Director, Atty.
