RESOLUTION NO. 2018-98

A RESOLUTION ADOPTING REPUBLIC ACT NO. 8972 ENTITLED "AN ACT PROVIDING FOR BENEFITS AND PRIVILEGES TO SOLO PARENTS AND THEIR CHILDREN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES"

WHEREAS, this Act shall be known as the "Solo Parents' Welfare Act of 2000."

WHEREAS, the Sangguniang Bayan of Gloria through the Municipal Social Welfare & Development Office ensures that the benefits and privileges of Solo Parents and their children are carried out;

WHEREAS, the Municipal Government of Gloria assured that the comprehensive package of programs/services for solo parents includes livelihood, self-employment and skills development employment-related benefits, psychosocial, educational, health and housing services.


NOW THEREFORE, on motion of **Hon. Norma R. Paz, Chairperson**, Committee on Social Services, Women, Children, Family Relation, Elderly and Person with Disability and was jointly seconded by Hon. Nicandro F. Fabon, Jr. and Hon. Crispin J. Bawasanta, so be it;
