





RESOLUTION NO. 2018-99

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE LAND BANK OF THE PHILIPPINES (LBP) REPRESENTED BY ITS PRESIDENT AND CEO, ALEX V. BUENAVENTURA THROUGH HIS DULY REPRESENTATIVE, BRANCH HEAD, FERDINAND E. ABAS FOR THE INSTALLATION OF AN OFFSITE AUTOMATED TELLER MACHINE (ATM) UNIT WITHIN THE PREMISES OF THE MUNICIPAL COMPOUND

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 9, 2018 requesting to pass a resolution authorizing the local chief executive, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement by and between the Municipality of Gloria and the Land Bank of the Philippines represented by its President and CEO, Alex V. Buenaventura through his duly representative, Branch Head, Ferdinand E. Abas for the installation of an offsite Automated Teller Machine (ATM) unit within the premises of the Municipal Compound;

WHEREAS, this Sanggunian finds this MOA in order, pursuant to the provisions of Section 444, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance;

WHEREAS, the Land Bank of the Philippines, Pinamalayan Branch is the depository bank of the Local Government Unit of Gloria, Province of Oriental Mindoro;

WHEREAS, the Land Bank of the Philippines has signified its intention to install an offsite ATM unit at the premises of the Municipal Compound;

WHEREAS, the installation of Land Bank Automated Teller Machine (ATM) in the municipal compound will benefit not only the employees of the Local Government Unit of Gloria but also the teaching force of the Department of Education, the personnel of the Gloria Municipal Police Station, the personnel of the Bureau of Fire Protection and of its Gloria Clientele;

WHEREAS, to avail the installation of Automated Teller Machine (ATM) in the municipal compound, the local government unit shall enter into a Memorandum of Agreement (MOA) with Land Bank of the Philippines;

WHEREAS, the Municipality of Gloria, Oriental Mindoro is willing to allow the LBP to use portion of space of fifteen (15) square meters more or less of the Municipal Compound located in front of the Mayor's Staff Office for the ATM booth;

WHEREAS, as the ATM Payroll System is very important to ensure safe and secure transactions wherein salary of employees can be credited to their individual account;

WHEREAS, this body finds the said request to be of merit.

NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairman, Committee on Finance and Appropriation** jointly seconded by Hon. Nicandro F. Fabon, Jr. and Hon. Henry S. Soberano, so be it;


RESOLVED AS IT IS HEREBY RESOLVED that the LGU Gloria, thru its Municipal Mayor, German D. Rodegerio is authorized to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the Land Bank of the Philippines (LBP) represented by its President and CEO, Alex V. Buenaventura through his duly representative, Branch Head, Ferdinand E. Abas for the installation of an offsite Automated Teller Machine (ATM) unit within the premises of the Municipal Compound.

RESOLVED FURTHER, that the LGU represents and warrants that it has taken all appropriate and necessary steps/actions to authorize the execution and delivery of the said Memorandum of Agreement and to comply with, and observe the terms and conditions thereof.

RESOLVED FURTHERMORE, that copy of this resolution be furnished the Land Bank of the Philippines (LBP) for their information and guidance.


