MUNICIPAL ORDINANCE NO. 11 Series of 2019

AN ORDINANCE AMENDING THE TITLE AND SECTION 3 OF MUNICIPALS ORDINANCE NO. 12, SERIES OF 2016 ENTITLED "AN ORDINANCE PROHIBITING THE DRINKING OR CONSUMPTION OF ALCOHOLIC LIQUOR UPON PUBLIC STREETS AND OTHER PUBLIC PLACES; PRESCRIBING A PENALTY THEREFORE

WHEREAS, people's awareness and alertness are important factors in disaster preparedness.

WHEREAS, Drunkenness is one of the reasons why several villagers refused to leave their homes during preemptive evacuation called by barangay officials.

WHEREFORE, on motion of Hon. Crispin J. Bawasanta, unanimously seconded by all members present,

NOW THEREFORE BE IT ORDAINED, as is hereby ordained by the Sangguniang Bayan in session duly assembled that:

SECTION 1. The phrase "AND FOR OTHER PURPOSES" shall be added in the last part of the title of Municipal Ordinance No. 12, Series of 2016 to read as follows:

" AN ORDINANCE PROHIBITING THE DRINKING OR CONSUMPTION OF ALCOHOLIC LIQUOR UPON PUBLIC STREETS AND OTHER PUBLIC PLACES; PRESCRIBING A PENALTY THEREFORE AND FOR OTHER PURPOSES"

Section 2. Section 3 of Municipal Ordinance No. 12, Series of 2016 is hereby amended to read as follows:

Section 3. Regulated Act.

Section 3.1. No person shall drink or consume any alcoholic liquor in or upon any public street, public place, alley, park, school grounds or other public grounds or areas within the municipal limits of the Municipality of Gloria, Province of Oriental Mindoro.

Section 3.2. No store owner shall allow customers to drink within the vicinity of their store.

Section 3.3. Drinking in beaches shall be regulated by the respective Sangguniang Barangay in cooperation with the implementation of this ordinance.

Section 3. 4. As part of Disaster Risk Reduction Management Measures, no person shall sell and drink liquor in the following situations:

- a. during and after three (3) days of calamities;
- b. within forty eight (48) hours when there is declaration of typhoon signal; and
- in the evacuation center.

Section 4. Repealing Clause – Any ordinance, rule or regulation or part thereof which is inconsistent with any provision of this Ordinance is hereby repealed or modified accordingly.

Section 5. Effectivity. This ordinance shall take effect immediately after fifteen (15) days from the date a copy thereof is posted on a bulletin board at the entrance of the Municipal Hall, as the case maybe, and in at least two (2) other conspicuous places in the municipality.

RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 11, SERIES OF 2019, OF THE MUNICIPALITY OF GLORIA, ENTITLED "AN ORDINANCE PROHIBITING THE DRINKING OR CONSUMPTION OF ALCOHOLIC LIQUOR UPON PUBLIC STREETS AND OTHER PUBLIC PLACES, PRESCRIBING A PENALTY THEREFOR", AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT ORDINANCE

WHEREAS, the Sangguniang Bayan of Gloria, Oriental Mindoro submitted Municipal Ordinance No. 11, Series of 2019, entitled "An Ordinance prohibiting the drinking or consumption of alcoholic liquor upon public streets and other public places, prescribing a penalty therefor";

WHEREAS, the Committees on Peace & Order, Unification & Reconciliation, and Human Rights & Social Justice and Laws, Ordinances and Legal Matters reviewed and studied said ordinance and found out that the same was approved pursuant to Section 447 of the Local Government Code ("LGC of 1991");

NOW THEREFORE, BE IT RESOLVED, that the Sangguniang Panlalawigan finds Municipal Ordinance No. 11 Series of 2019, to be within the conferred powers of the Sangguniang Bayan of Gloria to enact ordinance under LGC of 1991, subject to full and continuing compliance with all related and applicable laws, rules and regulations which shall be the full responsibility of the LGU, Municipal Mayor and pertinent officials of the Municipality of Gloria in the implementation of the said ordinance.
