MUNICIPAL ORDINANCE NO. 12
Series of 2019

AN ORDINANCE PROVIDING HEALTH CARD AMOUNTING TO THREE THOUSAND PESOS (P3,000) TO PERSON WITH DISABILITIES OF THE MUNICIPALITY OF GLORIA PROVINCE OF ORIENTAL MINDORO.

WHEREAS, Article 5 paragraph 1 and 2 of UN Convention on the Rights of Persons with Disabilities (CRPD) states that “*States Parties recognize that all persons are equal before and under the law and are entitled without any discrimination to the equal protection and equal benefit of the law; and States Parties shall prohibit all discrimination on the basis of disability and guarantee to persons with disabilities equal and effective legal protection against discrimination on all grounds*”;

WHEREAS, the amount would be a big help to the PWDs in the Municipality whose livelihood activities are limited by their condition;

WHEREAS, the health card will help the extra costs that the PWDs may have because of their impairment.

NOW THEREFORE, BE ENACTED, BY THE SANGGUNIANG BAYAN OF GLORIA IN SESSION ASSEMBLED, BY VIRTUE OF POWERS VESTED IN IT BY LAW, THAT:

Section 1. Short Title – This Ordinance shall be known as the “*Financial Assistance to PWD 2019 of the Municipality of Gloria*”.

Section 2. Purpose – The purpose of this Ordinance is to help the extra costs PWDs may have because of their impairment.

Section 3. Acronym –

Section 4. Setting the Qualifications. The MSWD shall set the qualifications to identify the beneficiaries.

Section 3. Beneficiary – The following will benefit the financial aid: PWD with several classification can benefit like abandoned, abused, disability, handy cup, independent living, indigent, impairment, disable gifted, fits/seizures, marginalized disabled persons, mental disability and neglected orthopedically handicapped, persons with behavioral problems person with hearing impairment and person with visual impairment.

Section 5. Validation and Monitoring- Municipal Social Welfare and Development Office (MSWDO) shall conduct the validation and monitoring of the PWDs.

Section 6. Manner of Giving of Financial Assistance. All qualified person with disabilities shall be given a health card amounting to Three Thousand Pesos (Php 3,000.00);

Section 7. Application. Those applying for health card assistance should just submit the following:

1. Accomplished application form;
2. A copy of their PWD identification card issued by MSWDO and the Persons with Disability Assistance Office (PDAO);
3. original copy of their medical certificate;
4. Certificate of Residency

Section 8. Separability Clause

Should any Section or portion of this Ordinance be declared by any Court as unconstitutional or invalid, such decision shall not affect the validity of other Sections or provisions of this Ordinance and shall remain in full force and effect.

Section 9. Repealing Clause.


All other ordinances, rules and regulations that are in conflict or contrary to the provisions of this Ordinance hereby repealed or modified accordingly.

Section 10. Effectivity Clause.

This ordinance shall take effect immediately after fifteen (15) days from the date a copy thereof is posted on a bulletin board at the entrance of the Municipal Hall, as the case maybe, and in at least two (2) other conspicuous places in the municipality.





RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 12, S. 2019 OF THE MUNICIPALITY OF GLORIA, ENTITLED “AN ORDINANCE PROVIDING HEALTH CARD AMOUNTING TO THREE THOUSAND PESOS (P3,000.00) TO PERSON WITH DISABILITIES OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO”

WHEREAS, the Sangguniang Bayan of Gloria submitted Municipal Ordinance No. 12 S. of 2019, of the Municipal Government of Gloria, entitled “An ordinance providing Health Card amounting to Three Thousand Pesos (P3,000.00) to Person with Disabilities of the Municipality of Gloria, Province of Oriental Mindoro”;

WHEREAS, the Committees on Finance and Appropriations, Laws, Ordinances and Legal Matters, Health, Sanitation and Population and Social Services, Persons with Disabilities, Indigenous Peoples, Poverty Alleviation and Values Formation reviewed and studied said ordinance and found out that the same was approved pursuant to Section 447 of R.A. No. 7160 subject to the findings and conditions stipulated under the Committee Report No. 290-2019 which shall form part of this Resolution;

NOW THEREFORE, BE IT RESOLVED, that the Sangguniang Panlalawigan finds Ordinance No. 12, S. of 2019 to be within the conferred powers of the Sangguniang Bayan of Gloria to approve resolution under the R.A. 7160, subject to full and continuing compliance with all related and applicable laws, rules and regulations which shall be the full responsibility of the LGU, the Municipal Mayor and pertinent officials of Gloria in the implementation of the said resolution.


