INVITATION TO BID ITB No. 2020-014

Supply and Delivery of Materials for the Installation of Protective Barriers

- The Municipality of Gloria, through Municipal Disaster Risk Reduction and 1. Management Fund 70% amounting to Two Hundred Eighty Four Thousand Six Hundred Fifty Pesos (Php 284,650.00) being the approved budget for the contract (ABC) to payments under the contract for each item. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Municipality of Gloria now invites bids for Supply and Delivery of Materials for 2. the Installation of Protective Barriers. Delivery of Goods is required within thirty (30) days upon receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-3. discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
