**INVITATION TO BID
ITB No. 2020-006**

Supply and Delivery of Materials for the Completion of Multi-Purpose Building –Barangay Sta. Maria

1. The **Municipality of Gloria**, through the **Annual Budget under the 20% Development Fund Project of the Municipal Mayor** intends to apply the sum of **Seven Hundred Twelve Thousand Nine Hundred Ninety Two Pesos (Php 712,992.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for each item. Bids received in excess of the ABC for each item shall be automatically rejected at bid opening.
2. The **Municipality of Gloria**, now invites bids for the **Supply and Delivery of Materials for the Completion of Multi-Purpose Building – Barangay Sta. Maria**. Delivery of Goods is required within **thirty (30) days upon receipt of Notice to Proceed**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.



Bid opening shall be on **July 20, 2020 at 2:30pm at the Municipal Executive Conference Room 2**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Municipality of Gloria** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
