**INVITATION TO BID

**Supply and Delivery of One (1) Unit Brand New Sports Utility Vehicle (SUV)**

1. The **Municipality of Gloria**, through the **Annual Budget 2020 under the Office of the Municipal Mayor amounting to Two Million Pesos (Php 2,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for each item. Bids received in excess of the ABC for each item shall be automatically rejected at bid opening.
2. The **Municipality of Gloria**, now invites bids for the **Supply and Delivery of One (1) Unit Brand New Sports Utility Vehicle (SUV)**. Delivery of Goods is required within **thirty (30) days upon receipt of Notice to Proceed**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.



7. Bids must be duly received by the BAC Secretariat at the address below on or before **December 9, 2020 @ 1:00pm**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause.

Bid opening shall be on **December 9, 2020 @ 2:30pm at the Municipal Executive Conference Room 2**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Municipality of Gloria** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
