**INVITATION TO BID

**Supply and Delivery of Materials for the Construction of Centralized Warehouse at  
Kawayanan Village**

1. The **Municipality of Gloria**, through the **Supplemental Budget No. 2, 2020 under the General Services Office** amounting to **Three Hundred Twenty Nine Thousand One Hundred Eighty Pesos (Php. 329,180.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for each item. Bids received in excess of the ABC for each item shall be automatically rejected at bid opening.
2. The **Municipality of Gloria**, now invites bids for the **Supply and Delivery of Materials for the Construction of Centralized Warehouse at Kawayanan Village**. Delivery of Goods is required within **thirty (30) days upon receipt of Notice to Proceed**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.


