Invitation to Bid ITB No. 2020-028

Supply and Delivery of Materials for the Operation and Maintenance of Municipal Public Market (Tiangge Tent Repair)

- 1. The Municipality of Gloria, through Supplemental Budget No. 2, dated May 18, 2020 under the Market Services Office amounting to Two Hundred Fifty-Five Thousand One Hundred Fifty Pesos (Php 255,150.00) being the approved budget for the contract (ABC) to payments under the contract for each item. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Municipality of Gloria now invites bids for Supply and Delivery of Materials for the Operation and Maintenance of Municipal Public Market (Tiangge Tent Repair). Delivery of Goods is required within thirty (30) days upon receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bid opening shall be on December 14, 2020 2:00 PM at Municipal Executive Conference **Room 2**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. The Municipality of Gloria reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
