



## CONTRACT AGREEMENT

THIS AGREEMENT made the 10<sup>th</sup> day of *September 2021* between *Municipality of Gloria of the Philippines* of the one part and *Ecological Solid Waste Solutions Inc. of Rizal, Philippines* of the Philippines of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly *Delivery and Installation of SLF Equipment and Machineries (Type C Equipment: Heavy Duty Dual Power Bottle and Glass Crusher and Heavy Duty Dual Power Multi-purpose Shredder/ Pulverizer Machine)* and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *One Million Three Hundred Thousand Pesos Only (Php. 1,300,000.00)* with the contract duration of *forty five (45) days* upon receipt of Notice to Proceed

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *One Million Three Hundred Thousand Pesos Only (Php. 1,300,000.00)* or such other sums as may be ascertained, *Ecological Solid Waste Solutions Inc.* agrees to *Delivery and Installation of SLF Equipment and Machineries (Type C Equipment: Heavy Duty Dual Power Bottle and Glass Crusher and Heavy Duty Dual Power Multi-purpose Shredder/ Pulverizer Machine)* in accordance with his/her/its Bid.






