
CONTRACT AGREEMENT

THIS AGREEMENT, made this 30th day of September, 2022 between Municipality of Gloria, Oriental Mindoro, and Alberto Uy Construction & Development, Bongabong, Oriental Mindoro, Philippines

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Uniformed Barangay Hall in Barangay Andres Bonifacio, Gloria, Oriental Mindoro with ITB No. 2022-020 and the Entity has accepted the Bid for Four Million One Hundred Eighty-Seven Thousand Ninety-Six Pesos and Seventy-Four Centavos (Php. 4,187,096.74) by the Contractor for the execution and completion of such Works within one hundred sixty-eight (168) working days upon receipt of Notice to Proceed and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.


